- \_\_\_\_\_ Any subcontractor for electrical, plumbing, gas, and mechanical (heating / air conditioning / refrigeration) work must hold a valid contractor license from the appropriate state board and obtain a permit specific to this work.

I understand that by claiming exempt status I waive my rights for protection under the provisions of the State of Alabama General Contractors Licensing Law in the event of litigation involving activities resulting from the grant of this permit.
